Background

Additional OASIS and OASIS SB Awards are done through on-ramping. **OASIS Unrestricted plans to release a new on-ramping RFP for pools 2 and 6.** FBO currently lists the RFP drop date as May 31, 2018. While the RFP has not yet dropped, the Contracting Officer confirmed on June 12, 2018 that the release is still planned, although a new RFP drop date has not yet been set. Be ready when the on-ramp occurs by starting to prepare your bid now!

General Overview of OASIS

One Acquisition Solution for Integrated Services (OASIS) is designed to address agencies' need for a full range of service requirements that integrate multiple professional service disciplines and ancillary services/products with the flexibility for all contract types and pricing at the task order level. OASIS and OASIS SB are each a family of seven separate Government-wide Multiple Award, Indefinite Delivery, Indefinite Quantity (MAC-IDIQ). Each of the seven separate MAC-IDIQs will be individually referred to as "pools" within OASIS.

The objective is to provide Government agencies with total integrated solutions for a multitude of professional service-based requirements on a global basis. These professional service requirements may call for solutions that cross over multiple disciplines, include ancillary support, and require commercial and/or non-commercial items, using a variety of contract types including fixed-price (all types), cost reimbursement (all types), time and materials/labor hour, or a hybrid mix of contract types.

Pools 2 & 6 On-ramp and Eligibility

Of the OASIS seven pools the following two pools will be included in this on-ramp. On-ramping is occurring to add new awardees to promote greater competition at the task order level.

- Contractor must demonstrate relevant experience in the predominate NAICS code for the specified pool.
 - **Pool 2 - 541211, 541213, 541214, 541219, 541720**
 - **Pool 6 - 541712 Exception A**
- Contractor must demonstrate relevant experience on 5 projects. A Relevant Experience Primary “project” is defined as a single contract; or, a single task order placed under a master Single Award or Multiple Award Indefinite Delivery, Indefinite Quantity (IDIQ) task order contract; or a single task order placed under a Federal Supply Schedule, or, a single task order placed under a master Single Award or Multiple Award Blanket Purchase Agreement (BPA). A collection of task orders may also be considered as a project.
 - Each project must be worth a minimum of \$3 million/year.
- All relevant experience must have been completed within 5 years of the solicitation closing date, with at least one year of performance completed before the solicitation closing date.
- Contractors must demonstrate performance in at least 4 of the 6 Core Disciplines of OASIS. These Core Disciplines are Program Management Services, Management Consulting Services, Scientific Services, Engineering Services, Logistics Services, and Financial Management Services.
- The combined annual value of the 5 projects must meet or exceed \$25 million/year.

Scoring and Award Criteria

For each eligible proposal submission, a base scoring system will be used to determine the project’s score. All experience will be scored by the same evaluation criteria and scoring table that was used for the initial awards. OASIS has provided the lowest evaluated scores per pool for contract awardees.

OASIS-Unrestricted pools 2 and 6 were not filled during the initial OASIS award period and therefore do not have scores; however, the low-score for the SB pool 2 is 2250, and the low-score for SB pool 6 is 5450 (for reference, the maximum total score is 11,475).

- Relevant Experience under an OASIS NAICS or PSC Code -- Max 750 pts
- Individual Project Value -- Max 1250 pts
- Performance/Integration of Additional Core Disciplines -- Max 875 pts
- Multiple Locations (Places of Performance) -- Max 750 pts
- Subcontracting/Teaming -- Max 500 pts
- Ancillary Support Products and Services -- Max 500 pts
- Cost Reimbursement Projects -- Max 200 pts
- OCONUS Projects -- Max 200 pts
- Mission Spaces -- Max 200 pts
- Multiple Award Contracts/Task Orders -- Max 150 pts
- Relevant Experience Projects (Past Performance) -- Max 3000 pts
- Total Small Business Goals -- Max 1000 pts
- Government Systems, Industry Certifications, & Government Facility Clearances -- Max 2100 pts
