## CAPTURE OASIS - Q&A Update 2018-10-10

The OASIS Small Business (SB) Pool 1 On-Ramp Solicitation was released on September 10th with the intention of adding 190 new awardees to the contract. This is a huge opportunity for SBs with relevant experience in this pool. This solicitation's Small Business Size Standard is \$15 million; The relevant NAICS codes are listed below. Product Service Codes (PSC) that demonstrate performance in this area are also acceptable. The relevant PSC codes for Pool 1 are all Category R Support codes that have not been assigned to a different pool.

The proposal due date is less than a month away, so staying on top of all updates is critical to your success. **Proposals are due Thursday, November 8th at 11am EST.**

- There were multiple questions regarding the total project values. For the SB pool, each project used as a primary project must have a minimum annual value of \$150,000. The total value of the projects must equal or exceed \$750,000 annually, times the number of projects submitted. So, if three primary projects are submitted, the minimum annual value of those three projects combined is \$2.25 million, with each individual project worth \$150,000 or more. There is no annual project value required for Pool Qualification projects.
- The minimum score for award eligibility will be based on the top 190 proposals, and not on a predetermined minimum score. The minimum score from the initial Pool 1 awards selection will not be a de facto minimum for this on-ramp.
- A single company can bid on multiple Joint Venture (JV) or Contractor Team Arrangements (CTAs). The same relevant experience for the team member can be used in each teaming arrangement.
- The solicitation for this on-ramp was released on September 10th. Documents preceding this date should not be used for information regarding this proposal. All the modifications and amendments that have been posted in the period from September 10th to date refer to the current Pool 1 on-ramp.
